Boeing is a leading global aerospace company and the largest U.S. exporter. It designs, manufactures, and services commercial airplanes, defense products, and space systems for customers in over 150 countries. The company operates through three primary divisions:

- Boeing Commercial Airplanes (BCA): Produces commercial aircraft such as the 737, 767, 777, and 787 models.
- Boeing Defense, Space & Security (BDS): Develops military aircraft, satellites, and defense systems.
- Boeing Global Services (BGS): Provides aftermarket support including maintenance, modifications, and logistics services.

Boeing was founded in 1916 and is headquartered in Arlington, Virginia.

## 4. Revenue

For the twelve months ending March 31, 2025, Boeing reported:

- Total Revenue: \$69.44 billion.
- Q1 2025 Revenue: \$19.5 billion, a 17.7% increase year-over-year.
- The revenue breakdown by division for 2024 was:
  - Commercial Airplanes: \$22.9 billion (34.4%).
  - Defense, Space & Security: \$23.9 billion (36.0%).
  - Global Services: \$20.0 billion (30.1%).

## 5. Institutions with Buy Recommendations:

• Out of 25 analyst recommendations, 14 rate the stock as "Strong Buy" and one as "Buy", accounting for 60% of all recommendations.
