### 4. Revenue

For the fiscal year ending January 26, 2025, NVIDIA reported:

- Annual Revenue: \$130.5 billion (114.2% increase year-over-year)
- Q4 Revenue: \$39.3 billion (78% increase from the previous year)

This growth was driven by strong demand in data center and AI-related markets.

## 5. Institutions with Buy Recommendations:

Several financial institutions have recently issued buy recommendations for NVIDIA:
