Walmart employs around 2.1 million associates worldwide and is committed to helping people save money and live better through a people-led, tech-powered omnichannel approach.

- Costco Wholesale A membership-based warehouse club offering bulk goods at discounted prices.
- Target A general merchandise retailer known for its curated product selection and shopping experience.
- Kroger One of the largest supermarket chains in the U.S., focusing on groceries and related products.
- Home Depot A home improvement retailer specializing in construction products and services .

For the fiscal year ending April 30, 2025, Walmart reported:

- Annual Revenue: \$680.985 billion, a 5.07% increase from the previous year.
- Quarterly Revenue (ending April 30, 2025): \$165.609 billion, a 2.54% year-over-year increase.

5. Institutions with Buy Recommendations:

6. Analyst Sentiment Summary
