Atmos Energy is a major U.S.-based natural gas distributor, serving over three million customers across eight states in the South-Central region. Its core operations cover procurement, storage, and regulated distribution, with a pipeline and storage infrastructure supporting residential, commercial, and industrial clients. The company's earnings derive from rate-approved delivery charges under regulatory frameworks that ensure infrastructure cost recovery and revenue stability.

4. Revenue

Atmos does not publicly break out revenue by segment, but its regulated rate-base model ensures stability. The company reported FY 2024 EPS of \$6.83, topping guidance, and announced a 41% capex program increase, with 88% of capital spend focused on safety/reliability projects .

5. Institutions with Buy Recommendations:

Atmos Energy holds a “Buy” consensus: among 26 covering analysts, there are 16 Buys and 10 Holds, with zero Sells. Recent ratings: Morgan Stanley and JPMorgan maintain Buy, with price targets ranging from \$159–166.

6. Analyst Sentiment Summary

- Bullish views: strong FY 2024 EPS, enhanced capex plan (+41%), regulatory rate-base recovery benefits .
- Bearish views: rising credit risk due to debt, inflation pressure from customer bill CAGR ~8–9%, and higher financing burdens.
