Its operations span electric generation, transmission, and distribution, as well as natural gas transmission, distribution, storage, and processing. The company is also a leading developer and operator of regulated offshore wind and solar power, and the largest producer of carbon-free electricity in New England .

4. Revenue

- 2024: Operating earnings were \$2.4 billion (\$2.77 per share), up from \$1.7 billion (\$1.95 per share) in 2023.
- Q1 2025: Revenue reached \$4.08 billion, an increase from \$3.63 billion in the same quarter of the previous year.

5. Institutions with Buy Recommendations:

Analyst opinions on Dominion Energy are mixed:

- Guggenheim maintains a "Buy" rating with a price target of \$69.
- Barclays has an "Overweight" rating with a price target of \$55.
- Other firms like Morgan Stanley, JPMorgan, and Goldman Sachs have issued "Hold" or "Neutral" ratings with price targets ranging from \$52 to \$63.

6. Analyst Sentiment Summary
