NFG is a diversified, integrated natural gas company operating through four segments:

- Exploration & Production (Seneca Resources) drills in Appalachia, focusing on Marcellus and Utica shales.
- Pipeline & Storage owns ~2,800 miles of interstate pipelines and 31 storage fields in NY and PA.
- Gathering builds and operates gathering systems in Appalachia.
- Utility distributes gas to ~755,000 residential and commercial customers in western NY and northwestern PA.

Headquartered in Williamsville, NY, founded in 1902, with ~2,300 employees.
