4. Revenue

- FY 2024 net revenues: \$61.8B (reported Jan 16, 2025).
- Q3 2025: record \$18.2B quarterly revenue on strong IB/trading/WM (reported Oct 15, 2025).

(External trackers reflect the same FY 2024 scale.)

5. Institutions with Buy Recommendations:
